1 DURATION OF CONTRACT AND CANCELLATION:

- 1.1 This contract will start on _____ and will continue until either party gives notice of his/her intention to cancel this agreement until 31 December _____
- 1.2 A payment R 250.00 (two hundred and fifty) non-refundable registration fee shall be payable.
- 1.3 This agreement may be cancelled by giving 90 (ninety) days notice in writing. Full fees are payable during this notice period of 90 (ninety) days.

2 TUITION & COSTUMES FEES:

- 2.1 The fee structure for lessons and costumes is as per annexure Fee Structure attached.
- 2.2 The RBA SA is closed during government school holidays or public holidays unless arranged as per par.2.3. The tuition fee will however still be payable as per par.2.1.
- 2.3 Students who are available during school holidays may attend classes as arranged with the relevant teachers at no extra cost.
- 2.4 The RBA SA reserves the right to withhold lessons if fees are not paid in accordance with ad par 2.1.

3.2 Trainee teachers under the supervision and direction of the principal Teacher, will from time to time assist in teaching classes in order to gain the experience and to qualify as Vaganova Ballet Teachers.

4 OTHER FEES APPLICABLE

4.1 Additional fees will be charged on an ad hoc basis for events, such as master classes with qualified and experienced foreign teachers.

4.2 Attendance of master classes will be made available to all students in accordance to the level and age and will be strictly voluntary.

5 IDEMNITY

5.1 The RBA SA will take all necessary precautions to avoid injury to student dancers whilst training, however the RBA SA will not accept responsibility for any injury sustained during trining sessions.
